You are being asked to be a volunteer in a research study.

**Purpose:**

The purpose of this study is to learn more about the student experiences at Georgia Tech.

**Exclusion/Inclusion Criteria:**

All Seniors petitioning for a degree are being asked to participate.

**Procedures:**

You are being asked to participate in the a brief web-based survey about your experiences and attitudes about Georgia Tech. Students will be asked about their experiences with faculty, their view on what they have learned, experiences with facilities and support services, and participation in co-curricular experiences, such as undergraduate research or the Co-op program.

Your taking the 15 minutes or so to take this survey will provide feedback about student learning and experience at Georgia Tech. You may choose to skip any items on this survey that you are not comfortable with or do not wish to answer.

Feedback is also available for other programs and services within the institution. With your permission, this data may be used in more detailed analysis of experiences and outcomes, with potential for publication.

**Risks or Discomforts:**

The risks involved are no greater than those involved in using a computer.

**Benefits:**

You are not likely to benefit directly from this study. The survey results will be used to provide feedback to academic units for self-assessment and program evaluation, including accreditation. Feedback will also be provided to other programs and services within the Institution. These results may shape future policies and programs related to undergraduate education and experience.

**Compensation to You:**

While we appreciate your involvement very much you will not be paid for your participation, nor are there any costs to you to participate except for your time.

**Confidentiality:**

Please be assured that your answers are confidential. The following procedures will be followed to keep your personal information confidential in this study: The data that is collected about you will be kept private to the extent allowed by law. To protect your privacy, your responses will be kept under a code number rather than by name. All data will be kept in secure files and only study staff will be allowed to look at them. Your name and any other fact that might point to you will not appear when results of this study are presented or published. Please be assured that your participation or non-participation will not affect your status at Georgia Tech.



You should be aware, however, that the experiment is not being run from a "secure" https server of the kind typically used to handle credit card transactions, so there is a small possibility that responses could be viewed by unauthorized third parties (e.g., computer hackers). Also, in general the web page software will log as header lines the IP address of the machine you use to access this page, e.g., 102.403.506.807, but otherwise no other information will be stored unless you explicitly enter it.

To make sure that this research is being carried out in the proper way, the Georgia Institute of Technology IRB may review study records. The Office of Human Research Protections may also look at study records.

There are no costs to you, other than your time, for being in this study.
